G.1 Approve Resolution to Adopt MSBO/MAPT Bus Purchasing Program

RATIONALE: By adopting this resolution, the Board of Education indicates its intent to participate in the MSBO/MAPT purchasing program. School boards are required to approve the resolution to purchase busses from the state bid.

G.2 Approve Purchase of School Bus

RECOMMENDED MOTION: "That the Chippewa Valley Board of Education approve the purchase of one (1) 2014 ThomasBuilt Saf-T-Liner C2 65-Passenger School Buses with a wheelchair lift and three (3) 2014 ThomasBuilt Saf-T-Liner C2 77-Passenger School Buses from the 2013/2014 MSBO/MAPT Bus Purchasing Program for a total cost of \$365,335.60."

RATIONALE: The Director of Pupil Transportation has compared the specifications of the offerings from each of three (3) manufacturers represented in the purchasing program and has made the determination that the recommended bus model will best serve the district at this point based on the performance of our latest purchases and other comparative factors. Funding for the purchase will come from the 2010 Building & Site Fund.

BE IT FURTHER RESOLVED, that no Board of Education member or employee of the school district shall expend any funds or obligate the expenditure of any funds except pursuant to appropriations made by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board. Changes in the amount appropriated by the Board shall require approval by the Board.

BE IT FURTHER RESOLVED, that the Superintendent and his designee are hereby charged with general supervision of the execution of the budget adopted by the Board and shall hold the department heads responsible for performance of their responsibilities within the amount appropriated by the Board of Education and in keeping with the budgetary policy statement hitherto adopted by the Board.

This appropriation act resolution is to take effect on approval by Board of Education.

RATIONALE: In preparing the 1st amended budget, the administration has reviewed the entire budget and updated the budget to reflect current information. Projected revenue decreases from \$142.7 million to \$142.2 million dollars while projected expenditures decrease from \$141.5 million to \$141.4 million. The changes result in revenues exceeding expenditures by \$800,000 as compared to revenues exceeding expenditures by \$1.2 million in the budget adopted in June 2013.

The total revenue variance is a negative 0.35% of the June budget while the total expenditure variance is a positive 0.07% of the June budget.

G.6 Approve 2014 Summer Tax Collection Agreement for Charter Township of Clinton and the Charter Township of Macomb Mr. Sederlund

RECOMMENDED MOTION: "That the Chippewa Valley Board of Education approve the Intergovernmental Agreement between Chippewa Valley Schools and the Charter Township of Clinton and the Township of Macomb for the collection of the 2014 summer taxes on the Clinton Township and Macomb Township parcels; authorize the cost to be pro-rated between the general fund and debt fund; authorize Board of Education Officers, Superintendent and Assistant Superintendent for Business and Operations to execute agreements as appropriate; and waive the reading of agreements."

RATIONALE: Each year the district must go through the legally prescribed procedure for collection of summer taxes. Chippewa Valley Schools (CVS) requested Clinton Township and Macomb Township to collect summer taxes for the district in 2014.

For 2014, Clinton Township has increased their collection fee to \$1.73 per parcel which is \$0.03 more per parcel than in 2013. Macomb Township has increased their collection fee to \$1.75 per parcel charge, which is \$0.25 more per parcel than in 2013. CVS will pay the \$1.73 and \$1.75 per parcel and CVS will collect \$0.17 and \$0.15 per parcel from MISD and MCC, respectively.

Not collecting summer taxes would have a significant impact on district cash flow and would result in the district borrowing up to \$14,000,000 with a significant borrowing cost.

G.7 <u>Approve New Board Policies #1623, #3123, #4123/Section 504/ADA Prohibition</u> <u>Against Disability Discrimination in Employment</u> Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the new board policies #1623-Administration; #3123-Professional Staff; #4123-Classified Staff/Section 504/ADA-Prohibition Against Disability Discrimination in Employment and that the reading of these policies be waived."

RATIONALE: These new policies are being adopted in the respective sections to address 504/Americans with Disabilities Act implications as they pertain to employment.

G.8 Approve New Board Policy #1422 & Revised Board Policies #3122/#4122-Nondiscrimination and Equal Employment Opportunity Mr. Roberts

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve a new board policy #1422 – Nondiscrimination and Equal Employment Opportunity/Administration and revisions to board policies #3122-Professional Staff; #4122-Support Staff/Nondiscrimination and Equal Employment Opportunity and that the reading of the policies be waived.

RATIONALE: The new board policy needs to be adopted and other policies be revised in response to Equal Employment Opportunity Commission (EEOC) rules regarding Protected Class status. In the area of employment law, courts, along with the EEOC, now recognize sexual orientation and transgender orientation to be encompassed under the term "sex". It is recommended that the specific language be included in the policies. Revision to these policies reflect the current state of the law and should be adopted to maintain accurate policies.
