Curriculum Updates – None

Administrative Reports

- Dr. Donald Brosky (Asst. Superintendent, Educational Services) reviewed the districts Emergency Operations Procedures (EOP) with the Board of Education. These procedures are put in place to identify and respond during, before and after an incident occurs. These procedures must be reviewed every two (2) years with law enforcement agencies that have jurisdiction over the district.
- Ms. Sarah Monnier-White (Director, Technology) provided the Board with an overview of the proposed Artificial Intelligence (AI) Guidelines for the district. Ms. Monnier-White detailed the appropriate and responsible use of artificial intelligence, including generative AI tools, in classroom instruction, school management, and system-wide operations.
- Mr. Paul Sibley (Exec. Dir, Secondary Education) discussed the challenges faced this year for middle and high schools offering the PSAT to 8th, 9th, and 10th graders and the SAT and WorkKeys test for 11th grade students, per state requirements and the district's preparation for students for their 11th grade SAT college entrance test. This year, changes in the testing format and the transportation challenges, have necessitated that the district schedule virtual education for the afternoons of testing days.

Mr. Sibley indicated the district will be utilizing Emergency Days as described in the Pupil Accounting Manual. The Chippewa Valley Schools Board of Education supported the plan.

Superintendent Roberts discussed the following:

- Mr. Roberts discussed the need for a non-homestead millage election. These are periodically required (every ten years in Chippewa Valley). The successful passage of this millage is necessary for the district to receive full funding for students. The millage only impacts non-primary residences (business and commercial property and second homes). The success of this millage is critical to fully fund district operations as it represents \$16 million of our district budget. The Board will be asked to approve an August election.
- Mr. Roberts recognized the quality of Mamma Mia! performed at Dakota High. He also recognized the C.T.E. students honored at the board meeting this evening. He related these two items to underscore the importance of collaboration in the pursuit of quality.

Superintendent Ron Roberts read and discussed guidelines and protocols when addressing the Board of Education during From the Community portion of the agenda.

From the Community

- Member Gura congratulated the C.T.E. students at the meeting. He spoke of the CVHS Fashion Show that he attended. He also recognized the student performance of Mamma Mia! He thanked parents for their support of the musical production.
- Member King was impressed with the performance of Mamma Mia! at Dakota High School. Mr. King spoke of the people who address the Board in *From the Community* who do not represent the community. He expressed the belief that although speakers have a right to express themselves some of the comments are inappropriate. Mr. King expressed his belief that hatred and the use of slurs should not be tolerated. He suggested that people use their energy to provide positivity.
- Member Wade thanked and complimented Dr. Brosky on his presentation of the district's Emergency Operation Plan.
- Ms. Aquino congratulated Mr. Terry Wilson as the new CVHS varsity football coach. She recognized both the C.T.E. program and students that were honored this evening. Ms. Aquino expressed pride in the district and its commitment to quality. She also spoke of the importance of equity, which she believes is provided in Chippewa Valley Schools.

MOTION #02/09/24 – Moved by Member Gura and supported by Member King that the meeting be adjourned into Executive Session (*8.b. – Student Expulsion Hearing*).

A roll call vote was taken. Member Gura, yes; Member Wojtowicz, yes; Member Sobah, yes; Member Wade, yes; Member King, yes; Member Aquino, yes and Member Pearl, yes Motion carried.

Meeting adjourned into Executive Session at 10:24 p.m.

Meeting reconvened into Open Session at 11:09 p.m.

MOTION #02/10/24 – Moved by Member Sobah and supported by Member Wade that the Chippewa Valley Schools Board of Education conducted a hearing on February 12, 2024, in a closed session concerning the Administration’s recommended expulsion of Student, 02/12/2024-DHS01.

The Student and the Student’s parents were advised, in writing, of the charges against the Student, the Administration’s recommendation of permanent expulsion and all other due process rights required by the law and District policy.

The Board of Education, based on evidence introduced at the hearing, concluded Student 02/12/2024-DHS01 violated Sections IV of the Student Code of Conduct, entitled, “IV.10, “*Drug Possession or Use.*” The Board of Education also considered the following factors and concluded the Administration had rebutted the presumption against long-term suspension or expulsion: the Student’s age; the Student’s disciplinary history; whether the Student is disabled; the seriousness of the Student’s misconduct; whether the Student’s misconduct threatened the safety of any other student or staff member; whether restorative practices will be used to address the Student’s misconduct; and, whether a lesser intervention would properly address the Student misconduct.

THEREFORE, IT IS RESOLVED: Student 02/12/2024-DHS01 is permanently expelled from the Chippewa Valley School District and is prohibited from entering any premises owned, operated or controlled by the District or attending any District-related function.

CHIPPEWA VALLEY SCHOOLS CELEBRATING READING MARCH 2024

WHEREAS The ability to read, write and communicate is empowering;

WHEREAS Communication provides a connection to who we are and how we live together and interact with the world;

WHEREAS People who are literate can read for many purposes and participate in society by interacting with various forms of communication;
