MOTION #05/04/15 – Moved by Member Patzert and supported by Member Cardamone that the Board of Education conducted a hearing on May 04, 2015 in a closed session concerning the Administrations recommended expulsion of Student 05/04/15:MHS01.

The Student and the Student’s parents had been advised on the charges against the student in writing, and had been advised of their due process rights. The Student was provided with all due process rights required by law and District policy.

The Board has considered all of the evidence presented at the hearing and based on the evidence has reached the following conclusion: Student 05/04/15:MHS01 was guilty of Section IV.5, *“Possession of a weapon”*.

Therefore, it is resolved that Student 05/04/15:MHS01 is expelled from the Chippewa Valley School District from 4/13/15 through the 1st term of Mohegan High School ending November 2015; at which time he may apply for reinstatement with successful completion of credit recovery and counseling. Student 05/04/15:MHS01 is prohibited from entering any premises owned, operated or controlled by the District or attending any District function. Ayes, all. Motion carried.
