G.1 Approve a Bid Award for Electrical Parts and Supplies Mr. Sederlund

RECOMMENDED MOTION: "That the Chippewa Valley Schools Board of Education approve the sole bidder, Graybar, for a two-year contract for electrical parts and supplies, with opportunities for four additional annual contract renewals, in the approximate annual amount of \$37,308.51."

RATIONALE: Aggressive pricing was obtained through the public bidding process RFB 3.1415. This award represents a 14% savings over our current contract.
