*Please note that children must be scheduled in Eleyo to attend, and that attendance approval is on a first come/first serve basis until we reach maximum capacity for that day. It is strongly recommended that you choose your expected attendance dates as soon as possible, as camp fills quickly. Please call to check availability for same-day drop-ins, a Director may be able to add children to the schedule if there is space available.

*** All accounts must be current in order to attend.**



Auto Pay is required

A current credit/debit card is required to be in Eleyo for AutoPay, which is processed each Friday for the previous week's services. Billing statements are posted each Monday morning and e-mailed to the address on file in Eleyo.

If payment fails to process, parents are responsible for correcting the billing information and making a payment in Eleyo before the child may return to camp. Families with outstanding accounts may not attend until their account is current.

A \$5.00 late payment fee will be assessed each week.

PaySchools Events



There are optional items that may have an additional cost, such as field trips, lunches, and special activities. Please refer to the camp calendar and events list for these activities.

PaySchools Events is utilized for optional purchases. Please note that although purchases are labeled "tickets", you will not receive an actual ticket. Staff will run reports, thus eliminating the need to print or email receipts.

Registrations are accepted in PaySchool Events until the bus is full, or maximum number of participants is reached, when full the activity will no longer appear as an option. There is a Sign-up Genius waiting list link available in PaySchool Events. A signed permission slip is required for all off-site field trips, along with a waiver for swim trips, which are on Payschool Events and the SACC web page, along with printed copies available at camp.

STATE OF MICHIGAN CHILD INFORMATION RECORD

A Child Information Record form is generated from the information that a parent enters in Eleyo at the time of registration. Please verify that all information is correct and make a Director aware if you update your information after the start of camp, so that we may print an updated hard copy.



Medical Needs



If your child has any medical needs or requires medication, signed medical authorization forms which can be found on the district website, along with the labeled medications, must be provided to S.A.C.C. prior to attendance.



Lunch and Snacks



Campers should bring a labeled water bottle, lunch, and two extra snacks daily.

*Please note there are some field trips and activity days that lunch is offered, or a sack lunch from home is required.

We are a Peanut/Tree nut Alert Program
There are children present with severe nut allergies, therefore we ask for you help to keep our campers safe by carefully checking labels of all food brought to camp.

If your child is attending any other camps or activities at the school, they must be signed in/out by an authorized person and our staff must be made aware of when they are expected to leave and return to the SACC program. Please speak with the Program Director to communicate information regarding attendance.

Campers may be divided into age level groups for activities throughout the day. Groups are designated by the grade the child has just completed.

Electronics



A designated time, usually at the beginning and end of the day, will be allocated for the use of electronic devices. Please note that these items must be labeled with the child's name and stored in their backpacks when not in use. Only school appropriate games are allowed, no social media, pictures, videos, texting, or phone calls are allowed without Director permission. Electronic devices are the responsibility of the child. The SACC program will not assume responsibility for lost, stolen or damaged property.



Water Play Days



Cool off with sprinklers, water balloons and more!

Please wear bathing suit under clothing, bring LABELED towel, flip-flops/water shoes, and plastic bag for wet items, sunglasses and hats optional!

Don't forget to take your items home with you!



Sunscreen



Sunscreen is supplied by the parents and must be labeled with child's name. SACC does not supply sunscreen. Only siblings may share the same sunscreen. *Staff cannot apply sunscreen to children, but may help direct application of lotion or spray. In order to bring in and use sunscreen, the Sunscreen Consent must be agreed to when registering in Eleyo. It is suggested that sunscreen be applied before dropping off children. Campers will be outdoors for a minimum of one hour each day.
